REGISTRATION CONDITIONS AND POLICIES

1. I agree to allow my child to participate in all activities. 2. The Director reserves the right to terminate the stay of any participant if in the opinion of the Director it is in the best interest of either the child or the camp. In such an event, it is understood that at the discretion of the Director, either no refund or a proportional refund, minus \$150 admin. charge may be made. Refund, if any, will be processed by the last business day in July 2012. 3. I release and indemnify CRAFTYCOUTURE (CC), its employees and guest instructors from all claims & liabilities whatsoever by my child arising from participation or attendance in current or future programs. 4. While CC is fair in providing sufficient notice of cancellation and not cancelling a session prematurely, if an insufficient number of participants have registered for a particular session, CC reserves the right to cancel such program. If a session has to be cancelled and no convenient alternative can be arranged, payment, (if any) already made will be fully refunded. 5. REFUND POLICY: Any payments made are refundable (less an admin. charge of \$150 per child) provided written notice is received prior to three weeks before the start of the session. After this time, there will be no refund of fees. All cancellations must be made in writing. Pro-rated refunds/credits and/or make-up days or partial days are not available for days absent. 6. NSF POLICY: CC acknowledges a cheque returned due to non-sufficient funds must be replaced immediately with cash or certified cheque covering the full amount owing together with an additional administrative charge of \$25.00. After two NSF cheques in a calendar year, parents will be required to pay by cash or certified cheque for any future programs. 7. I allow CC to take photographs/video/audio of my child and use their written endorsement for publicity purposes. 8. I have read and understood the Conditions & Policies and hereby agree to all terms.
